What types of personal information are collected and by who?

We may collect and use the following personal information:

Why are we collecting and using your personal information?

CAPTIVATE Study

Your personal information will be collected, used, stored and disclosed for the purposes of managing and conducting the CAPTIVATE study and complying with applicable laws and regulations relevant to the conduct of clinical trials.

Specifically, your personal information may be used:

- to contact you in relation to any operational aspects of the **CAPTIVATE Study**
- for data management services associated with the electronic data capture (EDC) system, such as providing access to and use of the EDC system
- to obtain ethics and regulatory approvals

Other research projects

We may also use your personal information to assess your suitability for potentially collaborating on other clinical trials or research projects that we are working on now and in the future and to contact you for that purpose. We will only use your personal information for this purpose if you consent by signing and returning this form (see Part B below)

What will happen if you do not wish to provide your personal information? Who might we disclose your

personal information to?

This is likely to limit the extent of your involvement or prevent you from being involved in the CAPTIVATE study.

Will your personal information be disclosed to overseas recipients?

For individuals residing in Australia, your personal information may be accessed by or disclosed to third party service providers involved in the CAPTIVATE Study located in New Zealand. For individuals residing in New Zealand, your personal information will be transferred to TGI (Study Sponsor) in Australia and may also be accessed by or disclosed to third party service providers involved in the CAPTIVATE Study also located in Australia.

How can you access and correct your personal information or make a complaint about a breach of the Australian Privacy Principles?
